All bidders must attend the compulsory briefing session and if not, their bids will not be considered.

In terms of Preferential Procurement Regulations of 2011 the 90/10 preference point system is applicable. Broad- Based Black Economic Empowerment (B-BBEE) requires that bidders should submit original and valid B-BBEE Status Level Verification Certificate **or if not original**, certified copies thereof to substantiate their B-BBEE rating claims. Failure to submit such certificate will result in the bidder not qualifying for preference points for B-BBEE.

The bidders must submit verification certificates that are accredited by SANAS (South African National Accreditation System) IRBA (Independent Regulatory Board of Auditors)
