





IMPORTANT NOTICE: Should the tax clearance certificate NOT be attached or not be the original copy or not be signed by SARS the bid will be regarded as invalid.

No faxed or e-mailed bid will be accepted. Company Registration Certificate indicating % ownership of each Director/ Manager/ Shareholder and **Original receipts** issued by the department must be attached to the bid documents and if not the bid will not be considered for evaluation.

In terms of Preferential Procurement Regulations of 2011 the 90/10 preference point system is applicable. Broad- Based Black Economic Empowerment (B-BBEE) requires that bidders should submit original and valid B-BBEE Status Level Verification Certificate or original certified copies thereof to substantiate their B-BBEE rating claims. Failure to submit such certificate will result in the bidder not qualifying for preference points for B-BBEE. The bidders must submit verification certificates that are accredited by SANAS (South African National Accreditation System) IRBA (Independent Regulatory Board of Auditors)
